***As a Garland Power & Light customer, you can save money by improving your home's energy efficiency!***

By participating in GP&L's EnergySaver Program, you can reduce your energy consumption, save money on your monthly utility bill, and receive a generous utility bill credit for qualifying energy efficiency upgrades.\*

## **Air Conditioning Program**

GP&L's EnergySaver Program offers utility bill credits of up to \$800 for the installation of high-efficiency heating and cooling equipment. The credit amount is directly related to the efficiency of the replacement unit.

- Qualifying central units
  - Central Air Conditioning 16.0 SEER \$500/unit
  - Central Air Conditioning 17.0 SEER \$600/unit
  - Central Air Conditioning 18.0 SEER \$700/unit
  - Central Heat Pump 16.0 SEER \$600/unit
  - Central Heat Pump 17.0 SEER \$700/unit
  - Central Heat Pump 18.0 SEER \$800/unit

*Note: All units must meet a minimum of 12.0 EER. Total system change-out is required.*

- ENERGY STAR® window units
  - 8,000 Btu/hr. or smaller \$50/unit
  - Greater than 8,000 Btu/hr. \$100/unit

## Wholehouse Weatherization Program

Any one or a combination of these energy-saving upgrades may qualify you for up to a \$500 credit on your GP&L account:\*

- **Ceiling Insulation (existing and new insulation must be at least R-30)**
- **ENERGY STAR® Windows and Doors**
- **Window Solar Screens and/or Film**
- **Duct Replacement or Duct Sealing**
- **Weatherization to prevent air leaks**

## Commercial Lighting Program

A utility bill credit is available to GP&L commercial customers who install high-efficiency lighting. The program offers a \$100 credit per kW reduced, up to a 200 kW maximum.\*

## Solar Generation Program

Utility bill credits are available to customers who install a qualifying solar photovoltaic system of at least 4,000 watts (4 kW). The credit (\$0.75 per watt) is based on the total watts installed. The maximum credit is \$5,000.\*

\*The credit recipient must be a GP&L customer. Applications must be completed and submitted to GP&L within 30 days of installation. The credit will be directly applied to your GP&L account. Bill credits are available on a first come, first served basis until funding is depleted or until September 30, 2016, whichever comes first. No credits will be issued for applications received after September 30, 2016. Applications are subject to verification. If the verification cannot be completed, the credit will not be paid. Customers must have their upgrades installed by a licensed, qualified contractor. The unit must be placed in service in the GP&L service area. Removed equipment cannot be reused in the GP&L service territory. Existing homes and businesses only. Five (5) ton limitation per unit.
